Dear Congressional Leaders,

We, the undersigned organizations that are members of the military and veteran community and organizations who support the health and well-being of our military and veteran communities, write to urge you to fight for equitable access to health care for all service members, veterans, and their families. Recent attacks on health care access in the FY24 NDAA, Defense appropriations, and MilCon-VA appropriations bills threaten the health, safety, and well-being of our communities, and we anticipate additional attacks of this nature when these bills arrive on the floor. We urge you to fight back against any such harmful provisions, including:

- Anti-LGBTQ+ riders, including any rider that would prohibit, restrict, or defund any form of gender affirming care, and any other riders that would prohibit or restrict the right to freedom of expression of LGBTQ+ service members and veterans;
- Riders that would prohibit, restrict, or defund reproductive health care services for service members and veterans, including abortion and contraception; and
- Attacks against DOD's recent policies for non-covered reproductive health care services.

Throughout our nation's history, LGBTQ+ Americans have worn and continue to wear the uniform with honor and pride. Among transgender Americans, it is estimated that 1 in 5 will serve in the military at some point in their lives, 1 making DOD one of the largest employers of, and VA one of the largest healthcare providers for, transgender people in the country. Attacks on

necessary medical care for transgender service members, veterans, and their families are not just issues of equity and morality, they are a safety issue. Bans on affirming care threaten the mental, physical, and emotional health of transgender individuals. Such policies can exacerbate the existing impacts of discrimination on trans veterans' well-being. For example, while transgender adults serve in the U.S. military at 2 to 3 times the rate of the general adult population, transgender veterans die by suicide at twice the rate of their cisgender veteran peers and approximately 5.85 times the rate of the general population.² Transgender veterans can thrive when they are supported—including by accessing care they may need—but policies targeting them for denial of care can have harmful consequences for their health and well-being.

Eighteen states currently ban best practice medical care – surgical care and medication – for transgender youth, with a nineteenth state banning surgical care only.³ Five of those states have enacted felony penalties against those providing this medically necessary care to minors.⁴ An increasing number of proposed bans do not only apply to minors: nearly one-third of bills (29%) introduced in 2023 would ban or restrict care for both transgender children and transgender adults.⁵ For service members, veterans, and their loved ones who need access to this essential care, being denied care at DOD or VA may mean they are unable to obtain the care at all.

Similarly, restrictions and bans on reproductive health care, including abortion and contraception, harm our military and veteran communities. Veterans and service members have always faced unique barriers to abortion care, which are only being further compounded now that the Supreme Court has taken away the constitutional right to abortion.

As of June 2023, abortion is illegal in 14 states and other states are moving to severely limit access to abortion services. Unfortunately, service members are additionally subject to abortion

bans that apply to the military, meaning they may have to obtain leave and travel hundreds of miles for care outside of the military health care system, that they must then pay for out of pocket - if they are able to obtain care at all. For veterans, attacks on abortion care at VA would have the same harmful impact.

We urge you to fight back against dehumanizing attacks on our service members and veterans' health and bodily autonomy. Access to essential health care, including reproductive health care and medically necessary care for transgender people, is a human right. Every person should have access to the care they need - regardless of what they do, where they live, or where they are stationed.

It is the job of Congress to pass legislation that protects the rights of our service members and veterans. Members of our Armed Forces and veterans should never be expected to sacrifice their access to basic health care for their service. We urge you to oppose these cruel attacks on service members and veterans and ensure their access to this essential health care is protected.
