

ASRM 2024 Abstracts Frequently Asked Questions (FAQ)

The [ASRM 2024 Call for Abstracts](#) has all abstract details and guidelines. Please refer to this document for details about the ASRM abstract process.

How do I submit an abstract?

A link to the submission site is available on this page: <https://asrmcongress.org/presenters/>. ASRM 2024 abstract submission is open February 14, 2024, and closes April 24, 2024, at 5:00 PM Eastern Time. **No extensions to this deadline can be made.**

What is the maximum number of authors allowed on an abstract?

ASRM only allows for 25 co-authors on an abstract.

How do I make edits to my existing abstract?

Edits to abstracts can be made once submission opens on February 14, 2024, through close of submission on Wednesday, April 24, 2024, at 5:00 PM Eastern Time. You should follow the link in your email you receive from the submission system to access your abstracts for edits. Please ensure that all authors are added before the submission deadline.

Changes to be aware of:

1. Topic categories and subcategories have changed. Please choose the category and subcategory that BEST represents your abstract topic. To view the [list](#) click here.
2. **SUBMISSION CHANGES:** ASRM now requires *all authors (presenting and co-authors)* to login with an ASRM account id & password to access the submission and disclosure process. To prevent any delay in accessing the system, all abstract co-authors are encouraged to create an ASRM account before attempting to submit. You can setup an ASRM account anytime online [here](#).
3. The last day to withdraw without penalty has been moved up and is **June 19th, 2024.**
4. Our award opportunities have increased, and instructions have changed. This information can be found on the Congress website [here](#) Please review carefully.

Does ASRM have a Late-breaking abstract submission period?

No! ASRM will **NOT** have a late-breaking abstract submission cycle for the ASRM 2024 meeting.

When will I receive notification that my abstract is accepted or rejected?

Notifications regarding acceptance/rejection will be emailed to the **presenting author ONLY** beginning no later than June 5, 2024, to the email address listed for the presenting author. The presenting author should contact all co-authors for status updates. If the presenting author does not receive notification of the status of your abstract by June 15th, 2024, please call Technical Support at +1 (401) 334-0220 or email technical support at asrm@confex.com.

Should abstract presenters (poster or oral) register themselves for the ASRM 2024 Scientific Congress?

Yes! If you receive a letter of acceptance for your abstract for oral or poster presentation, you will be required to attend the ASRM 2024 Scientific Congress and Expo to present. **You must register yourself for the meeting even though you are a program participant. No discounts are offered to abstract presenters.** Registration rates and program information will be available here: <https://asrmcongress.org/register/>

Does ASRM provide a certificate of presentation?

No! ASRM does not provide a certificate of presentation for speakers or abstract presenters.

I need a letter of invitation to submit with my VISA application. Where do I get this?

You can find the letter of agreement online [here](#). This letter does not imply any financial support by ASRM. You may also use your letter of acceptance as additional supporting information if necessary.

Can I give my abstract presentation virtually?

No! ASRM 2024 is an in-person meeting. All presenting authors should register and be ready to present in-person at Congress.

Can I add or remove an author(s) to my abstract?

No! Once abstract submission closes on April 24, 2024, at 5:00 PM Eastern absolutely no edits can be made to the abstract. This includes adding or removing authors.
